### My Message Triangle

It's the holiday season! Time for spreading joy and cheer. No matter what holiday you celebrate, are you the person who does all the preparations? Do you feel like you spread yourself too thin? Would you like to have some help from your family and friends? Perhaps a message triangle is just what you need to use to get some assistance in your holiday preparations. A message triangle is a tool that you can use in

your personal or professional life to make an ask. It has three parts: anger, hope, and action. To illustrate this tool, I will make you angry, then I promise I'll give you some hope. I am optimistic that it may nudge or even launch you into action. That's the message triangle-ANGER, HOPE, and ACTION.

So let's begin with the first part of the triangle-ANGER. I know you are all stressed out. I am not here to judge, because I am right there with you! If you are like me, do certain words just get your blood boiling these days? OTES. Third Grade Reading Guarantee. Outsourcing. Privatization. Reduction in Salary and Benefits. Right to Work. Governor John Kasich. Just writing some of those words and phrases make me stressed out and angry. I would dwell on it, but I'm also preparing for yet another meeting and report! The Roman poet Horace once said, "Adversity has the effect of eliciting talents which, in prosperous circumstances, would have lain dormant." If Horace ever met John Kasich, he might reconsider. But in all seriousness, I do believe that to be true. Sometimes it's the worst of circumstances that bring out the best in people. I know we are all under stress and are facing adversity every day. I want you to know that despite all the adversity out there, there is HOPE, which is the second part of the message triangle.

After an 8 week strike last spring, Strongsville Education Association settled and received the fair and equitable contract they deserved. THAT GIVES ME HOPE. The Ohio Supreme Court decision on informational picketing ruled in favor of Mahoning Education Association of Developmental Disabilities. THAT GIVES ME HOPE. The November 2013 General Election had 14 active, retired, or OEA family members running for local offices, and 11 won their elections. THAT GIVES ME HOPE. Several mayors who supported SB 5 were also defeated in November, including Cuyahoga Falls Mayor Don Robart and Toledo Mayor Mike Bell. THAT GIVES ME HOPE. In the past few years, there has been unfair, unjust legislation against public education and unions. But just recently, Republican Senator Randy Gardner introduced SB 229 that would help make Ohio's new system for evaluating teachers more effective, fair and efficient, THAT GIVES ME HOPE. But most significantly, the OEA FCPE State Council unanimously endorsed a life long public servant and outspoken supporter of public education, Ed Fitzgerald, for Governor. He understands the difference a good school, a good teaching and support staff, and a good education can make for the next generation and he is ready to lead Ohio's education system into the future. Just a few weeks ago Ed announced his running mate, State Senator Eric Kearney of Cincinnati. Eric is known for being one of the most effective members of the Ohio legislature, able to reach across party lines to get things done. He is also a fierce advocate for Ohio's middle-class-families and children. THAT GIVES ME HOPE. THEY GIVE ME HOPE.



Delegates unanimously voted to endorse candidate Emilly Osterling for NEA Director #1 who is running unopposed. Tracy Lemus Santos (Fairless EA) was elected to the office of ECOEA Vice-President, term expiring 2015. Elected to the ECOEA Executive Committee were Dr. Geneva Parker (CPEA) for Stark #4 Rep ('15), Karen Linch (Wooster EA) for Wayne #2 ('14) and ECOEA Rep to the OEA Professional Efficacy Core Function Committee is Ramona Moore (Lake Local EA). ### My Message Triangle by Angela Stewart

Illustrator Mary Engelbreit says, "If you don't like something change it; if you can't change it, change the way you think about it." I don't know about you, but I don't like the direction our current governor has taken us and continues to take us. The damage Governor Kasich has done, not just to public education, but to Ohio's middle-class is absolutely unacceptable. Think about all the policies and legislation that have been passed under his control and he needs to run for reelection. Now imagine all the policies and legislation that could be passed when he doesn't need to run for re-election. Does that make you angry? But after hearing about Ed Fitzgerald and Eric Kearney do you feel some hope too? Anger without hope can become cynicism and apathy, but anger with hope becomes action. We may not be able to change the game, but we can change the players-and the coach! Will you join me in ensuring our future, our careers, our union prospers despite the adversity being sent our way? What are you willing to do? Will you screen candidates to ensure quality people are representing us? Will you make phone calls or knock on doors for those candidates that support public education and unions? Will you make a contribution to FCPE or even to a candidate's campaign? If you think politics doesn't affect you, look around! Legislators are constantly drafting legislation that impacts us; often creating intended or unintended, negative consequences. We must be vigilant. Now is the time to rebuild our Fund for Children and Public Education monies. Our monies need to be spent on supporting those issues and candidates that support public education and our unions; candidates like Ed Fitzgerald. It is vital to the survival of public education that we be able to raise money for our cause, to make a change in the line up. Let's face it, in politics, money talks! So let us be heard! Don't let your voice or the voices of your colleagues only be heard around the lunch table lamenting all the terrible things that are happening to public education. Take action and make them be heard in Columbus and around the state. OEA cannot use dues dollars for political campaigns, so it is our responsibility to contribute to the Fund for Children and Public Education. If you haven't had an FCPE Drive in your local, or if you have never made a contribution yourself, I implore you to do so. There will be a statewide FCPE Drive this spring as well and local presidents will be receiving more information and tools when it draws closer. Bottom line is you need to make that connection to your members about how important FCPE is and how it affects them and their future. Talk to your members about supporting their profession, regardless of what party they belong to. And if you want them to jump into action, try using the message triangle with them: ANGER-HOPE-ACTION!

The following words of wisdom are from two very different people, but they share the same core message. The first is from nationally known commentator Michael Josephson. He said, "The surest way to escape anxiety and defeat despair is action. Do, don't dwell." The second is from American folk singer Joan Baez. She said, "Action is the antidote to despair." Let's cure what ails us and take action! So stay healthy this holiday season and enjoy some time with family and friends. Let's take some action during the new year and bring some new players to the game!
