WHY IS IT IMPORTANT....

MANY BILLS ARE DROPPING THAT AFFECT PUBLIC EDUCATION. STAY INFORMED & EDUCATE YOURSELF ABOUT THESE CRITICAL ISSUES

**There are 2 races still out (HD 7 & HD 98) Right now Republicans have 59 seats. 60 House seats= Republicans would have a 3/5 majority and would be able to put legislation on the ballot without collecting any signatures
66 House seats=Republicans would have 2/3 supermajority and could add an emergency clause to any legislation, making it effective immediately. They could also make any legislation referendum and veto proof. If this had been the case when Senate Bill 5 passed, it would be law today!**
