The Ohio Education Association Media Award for Public Service recognizes an individual and/or organization for a major contribution to the better understanding of the problems, progress, and needs of public education, or for programming of an outstanding educational nature.

Any member of the Ohio Education Association may nominate an individual or organization to receive this award by completing the nomination form and sending it to the office of the President of the Ohio Education Association by **January 12, 2016**. The OEA President, Vice President, and Secretary-Treasurer shall review the nomination(s) and supporting rationale. Based on their review and decision, they may submit a nomination for the award to the OEA Professional Efficacy Core Function Committee by **January 26, 2016**. **Current members of the OEA Board of Directors and the Professional Efficacy Core Function Committee are not eligible for this award. In addition, members of the Professional Efficacy Core Function Committee are not eligible for two years after completion of service on the committee to apply or be nominated.**
