The OEA President, Vice President, and Secretary-Treasurer shall review the nomination(s) and supporting rationale. Based on their review and decision, they may submit a nomination for the award to the OEA Professional Efficacy Core Function Committee by **January 26**, **2016**. **Current members of the OEA Board of Directors and/or the Professional Efficacy Core Function Committee are not eligible for this award. In addition, members of the Professional Efficacy Core Function Committee are not eligible for two years after completion of service on the committee to apply or be nominated.**

The Friend of Education Award is presented at the OEA Spring Representative Assembly as well as the OEA Awards Banquet in Columbus during the weekend of the OEA Spring Representative Assembly.

NOTE: The completed official application form **from the nominee** for the OEA Friend of Education Award must be postmarked on or before the **January 12, 2016** deadline.
