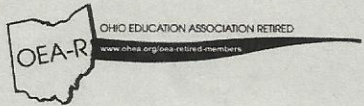

Dues payments are not deductible as charitable contributions for federal income tax purposes. Dues payments (or a portion) may be deductible as a miscellaneous itemized deduction. Lobby expenses paid or incurred as part of membership dues cannot be deducted from your income taxes. The amount of the OEA membership dues attributable to lobby expenses is estimated to be 12 percent of your 2014-2015 dues. Actual deductible dues dollars for the 2014 year will be reported in the January 2015 issue of Ohio Schools for all levels of membership.
