Nominations for elected officers shall be by declaration of candidacy and submitted in the following manner: 1. To the Secretary-Treasurer at least seventy-five (75) days prior to the election, 2. By the Nominations Committee at least forty-five (45) days prior to the election, or 3. By nomination from the floor of the OEA Representative Assembly for OEA statewide candidates or the appropriate district representative assembly for electoral unit candidates.
