- Equity and inclusion in curriculum/CRT

- 2. Why is it thought to be a good idea to require a year's worth of lesson plans be turned in before we have even met our students? Will teachers be "punished" if lesson plans are not followed exactly, because a good teacher adjusts to his/her students on an hourly, daily basis.
- 3. Why are people with zero education experience permitted to make decision on requirements in schools without the educators input?
- 4. Requiring teachers to submit lesson plans in June for an entire year.
- 5. What are you doing to strengthen Ohio's public schools? What are your thoughts on the "Backpack Bill?"

- 10. For Representative Hillyer: HB 322, 327 and 529 collectively make it more difficult to perform my duties to the best of my abilities. I am an educator with over 27 years of classroom experience, I have earned master's degree with a concentration on the US Constitution, continue my graduate studies with an additional 32 graduate credits of study covering the United States Constitution, a James Madison Constitutional Fellow, and I want to know why the GOP led legislatures are attacking social studies teachers and treating us as enemies of the state. The very introduction of these types of bills are demeaning and destructive to all classroom educators across the state.
- 11. If you take controversial issues out of the classroom then you leave thousands of American young people left to follow information from the internet, social media, and network news. Teachers are trained and experienced in helping students develop critical thinking skills, detecting bias, identifying reliable sources, and recognizing of facts and opinions. They remove student advocacy, interest, action, engagement, conflict resolution, and remove the very essence of good civic education that allows a free society to flourish.

- 22. - 29. Race as a wedge issue-Over the past year, CRT has been used to drive the electorate and to ensure they can win elections. Yet, no one has offered evidence on what this is. Yesterday, the Plain Dealer reported that Kim Richey, an applicant for the State Superintendent, said she will drive legislation to regulate "race-based instruction", yet does not provide examples on what this is. Will each of you tonight commit to ending the practice of using race as a wedge issue?
- 30. Windfall Act-After numerous petitions that were signed to abolish the Windfall Act, why have no representatives looked into this, to be put on the ballot for voting?
- 31. For Representative Oelslager, former ORSC member, there are two bills currently introduced to mandate that STRS pay retirees a COLA. Please share your thoughts regarding these bills.
- 32. HB 317-Divisive Concepts. Children need to be taught history accurately.
- 33.
