



### ECOEA SUMMER LEADERSHIP WORKSHOP AT STARK STATE COLLEGE

Over 90 members and presenters gathered at Stark State College for a full day of Professional Development on Monday, July 31st. All members heard from Sherri McKinney-Frantz, administrator for Stark County Children's Network Child Advocacy Center. Sherri provided an in-depth presentation on Human Trafficking. The day continued with morning and afternoon sessions that included the OEA Treasurer's Training and Quicken for Treasurers by OEA Secretary-Treasurer Tim Myers. Members also heard about scholarship opportunities from NEA Director Angela Stewart, NEA Member Benefits from Guy Kendall-Freas, and Pre-Retired membership from Kathleen Purdy.

Members chose from a variety of topics that included ESSA Update, Professional Code of Conduct, both presented by Ellen Adornetto, OEA Consultant. Two different Building Rep Training sessions were provided by OEA Labor Relations Consultants Sarah Drinkard, Ethan Young, and Don Holub. LRC Tom Booth provided Grievance Training. Local Leaders networked with ECOEA President Julie Nelson (North Canton EA President), ECOEA Recording Secretary Kelli Green (Perry CTA President), and ECOEA Committee Member Ed Sims (Rittman EA President). These local presidents shared their experience during the Local Leaders session. All members received PD certificates for their attendance at the workshop.







### EAST CENTRAL OHIO EDUCATION ASSOCIATION

ECOEA is governed by the actions of the Fall and Spring Representative Assemblies. Every local is entitled to send representatives through their local election process based on the membership size of the local. It is important that all locals participate in the Representative Assembly by electing and sending delegates. Representatives must be elected by October 10, and reported to OEA to be certified by October 15. All OEA delegates and alternates are automatically delegates to the ECOEA Representative Assembly. The delegates at the ECOEA RA elect district officers and Executive Committee members, approve the district budget including dues amounts, and approve district Constitution and By-law changes. Be sure your local is using their voice in this democratic process by electing and sending delegates.
