As I stated in my last article, I want to be able to provide local leaders with some tips to improve their locals. So, here is the first installment of the "A, B, C's to Build Involvement."

A is for Asking. If you want people to participate in any way, you must ask. It never hurts to just ask; the worst that can happen is they say no.

**B** is for Black Hole. People are afraid that if they volunteer, they'll be sucked into a black hole of time commitment from which they can't escape. Let them know up front that your local is not a black hole. Then, make sure you honor their time constraints.

**C** is for Communication. Use a variety of communication tools to make sure your message gets through such as e-mail, 10 minute meetings, newsletters, websites, social media, etc.

**D** is for **Diversity**. Reach out to all members in your local, not just the ones who are easy to reach. No one can do everything but everyone can do something!

**E is for Examine.** Look closely at your activities to decide what's working and what isn't. Do away with things that are not working and try something new. Don't be afraid to make changes! **F is for Fun**—don't forget about it! Some special people will dedicate their time and energy to a group because it is the right thing to do. Many, many more will participate if it's fun.

**G** is for Gradual. Introduce members to participation gradually. Invite them to work on a committee, write their legislator a letter, etc. and, with time, they might take on more responsibilities.

**H is for Hour,** the length to which you should limit meetings. More people will attend meetings if they know that it will not infringe on their time. In addition, when meetings last too long, people lose focus.

Keeping accurate records, understanding financial record-keeping, tax implications and filing, dues and membership are some of the very important topics that were covered.

Members in the OEA Affiliate Grant Writing session met with OEA Assistant Executive Director Kevin Flanagan to learn about the various OEA grants available to locals to encourage membership and FCPE participation. LRCs LaVonne Lobert-Edmo and Kim Borzyn led a work session with locals interested in bringing their Constitution and Bylaws into compliance.

After a delicious dinner buffet door prizes were awarded. NEA Member benefits and OEA-R representatives were on hand to explain their programs to our members.

After dinner, OEA LRC Gary Kovach, assisted by LRCs Alison Hoffa, Todd Jaeck, and Kristin Johannsson, conducted an excellent Building Rep training. Carol Price, OEA Staff, led Local Leaders through Elections training--the nuts and bolts of running an election, ballots, dates of various elections and reporting information, and federal laws governing elections. The Local Leaders continued in a networking session facilitated by ECOEA President Tracy Lemus Santos, VP Julie Nelson, and LRC LaVonne Lobert-Edmo. It was a full day of information for our Local Leaders as they prepared for a new year of association work.

## ECOEA FALL REPRESENTATIVE ASSEMBLY-NOVEMBER 7, 2015

The ECOEA Fall RA will be held at the Canton Professional Educators' Office on Saturday, November 7. Delegates, alternates, and guests will gather to conduct the business of the RA. We are delighted to present the ECOEA Leader of Distinction Award to two deserving ECOEA members for exceptional service to ECOEA. We will recognize the Top Ten Locals for the highest percentage of membership contributing to FCPE. This year we have 13 locals who qualified for the Five Star Award. These locals have met at least 5 of 6 criteria for active participation in ECOEA. Each local will receive a Five Star certificate and a drawing will be held to award a \$500 unrestricted grant to one of the locals.

We will also be awarding 4 ECOEA Public Relations Grants of \$500 to locals to use to promote their local and ECOEA within the community. In order to be eligible for a PR Grant, a local must **elect and send** delegates to the ECOEA RA in the previous year.

ECOEA Unit Scholarship drawings will be held. Each year, a \$500 scholarship is awarded to a member in each of the three ECOEA voting units. The scholarship is by lottery drawing at the RA and is to be used for the continuing education of our members.

We will also hear from the two candidates for the open NEA Director #2 seat—Tammy Koontz, SCOPE, and Sophia Rodriguez, Coldwater Teachers' Org. Candidate endorsement will be considered by the assembly.

### Pending Medicare B Premium Spike Would Hurt Ohio Public Retirees

It is anticipated that without Congressional action, Medicare B premiums for millions of Americans will increase by 52% on January 1, 2016. However, this increase would only be experienced by around 30% of enrollees, including many public education retirees in Ohio. The projected increase would be from \$104.90 a month to \$159.30 a month. Additionally, the premium increase will be accompanied by a hike in the Part B deductible—up to \$223 from \$147. The increased deductible would apply to all enrollees.

The projected increase in premiums is attributed to higher utilization of outpatient services than projected. However, at the same time, Social Security recipients will receive no cost of living adjustment (COLA) in 2016. Federal law has a hold harmless provision that limits increases in the Medicare B premium to the dollar increase in an individual's Social Security benefit. The premium increase would apply only to those without a Social Security benefit, new enrollees, and those who have income above a specified level. Because Ohio public employees do not pay into Social Security, many retirees do not receive benefits and therefore are not subject to the premium increase.

The National Education Association and 70 other organizations sent to a letter to Congressional leaders urging them to find a solution that addresses the inequity. OEA leadership has asked the same of Ohio's Congressional delegation. While lawmakers are working to advance a solution, the issue is complicated by the cost associated with the change and internal leadership battles in Washington.

## **OEA Fall Representative Assembly Information**

Locals who elected delegates to the OEA Representative Assembly are participating in the democratic governance of our organization. Delegates vote on our guiding documents, officers, dues, legislative policy, and much more. They listen to and participate in debate on the floor of the RA. They are part of the decision-making process that guides OEA. Every local should elect and send delegates so your voice is heard. Delegates will gather on Saturday, December 5, at the Ohio Expo Center, Voinovich Center on the Ohio State Fairgrounds. There are several new procedures for this year's RA at this new venue.

- Preregistration the night before at the host hotel will be from 6 PM to 9 PM. Delegates are invited to attend the Doris L. Allen Minority Caucus dinner at the hotel. A ticket order form will be included with your RA documents from OEA.
- Delegates arriving on Friday evening are invited to the Hospitality Event sponsored by the District Leaders Council at the host hotel beginning at 8:30 PM. DJ, dancing, networking, door prizes!
- Delegates should arrive early at the Expo Center for best parking. There are several other events going on at the Fairgrounds. Registration that morning begins at 7:30 AM.
- There will be no lunch break. You may not carry in food, other than a small snack such as a granola bar.
   There will be concession offerings ranging from hot dogs and wraps to box lunches, \$4-\$10. You may eat in the dining area or take the food back to your seat. Delegates are encouraged to pay with cash, not credit cards, to expedite lines at vendors.
- Voting will be continuous during the morning of the RA, such as we do at the NEA RA. You will be
  assigned your voting time. There will be one election for NEA Director #2 to fill the vacated seat.
- It is estimated that with no lunch break or unforeseen events that the RA will conclude about 1:15 PM.
- There is an open hearing for the Commission on Student Success open to any delegate or member immediately following the RA.
