A Message from Julie

It feels like over the past decade every election is "the most important election of your life." There is no denying that once again the results of November 8th will have an impact on our careers. Elected officials will decide how our schools are funded, how many tests our students are subjected to, how employees will be evaluated, how to address the epidemic of failing charter schools and what rights our union has.

While we may not agree completely with a candidate, our students need us to stand up and be a voice for them. Take time to visit and promote <u>www.ohioballot.com</u>. You can find which candidates support our positions on education and will work to champion our students and public schools. Share this information with your friends, family, and colleagues. We need to be an active part of the process and encourage everyone to take the time to vote. This election will be won one precinct at a time.

These candidates are chosen for endorsement through a transparent bipartisan screening process led by members. Depending on the race candidates are screened by OEA members serving on FCPE State Council or District Screening Councils. Candidates are invited to complete a written questionnaire and participate in an interview to discuss their views on educational issues like school funding and privatization. Recommendations for endorsement are made based on the candidates' records in office and their position on education issues.

As OEA attorney Kathleen McKinley shared at the ECOEA Legal Update on October 23, be careful how you address the election with students. Our personal free speech rights are limited when we have a "captive audience" in our classrooms, offices, and buses. Emphasize the importance of voting as a right and responsibility of a democracy.

Minerva Local Education Association teacher Julie Rine wrote <u>a blog post</u> <u>titled "The elephant and donkey in the room</u>" on the conflicted feelings this presidential election has created. She reminds us "In one of our schools today sits a future President, and how he or she views this great country might very well depend upon how we deal with the fallout of this election in our classrooms." The Louisville Education Association (LEA) in Stark County delivered a 10-day strike notice effective November 2, 2016. The LEA has been working without a contract since June 30th. The bargaining team is ready to engage in meaningful negotiations with the BOE and mediator. LEA represents approximately 180 full time and part time educators.




OEA Board of Directors-Unit 1-Three year term 2017-2020
